Any one of such joint holders may vote, either in person or by proxy, in respect of such share as if he/she were solely entitled thereto, but if more than one of such joint holders be present at the EGM or any adjournment thereof, whether in person or by proxy, the vote of the senior holder who tenders a vote, whether in person or by proxy, shall be accepted to the exclusion of the votes of the other joint holders, and for this purpose seniority shall be determined by the order in which the names stand in the register of members of the Bank in respect of the joint holding.
3. A member entitled to attend and vote at the EGM is entitled to appoint a proxy or proxies to attend and vote in his stead, subject to the Articles of Association of the Bank. A proxy need not be a member, but must attend the EGM in person to represent the shareholder. If more than one proxy is so appointed, a photocopy of proxy form may be used and specify therein the number of shares in respect of which each such proxy is so appointed.
4. If you do not wish to appoint the chairman of the meeting as your alternate proxy to the named proxy, please delete the words "or failing him/her, the chairman of the meeting". **ANY DELETION OR ALTERATION MADE TO THIS FORM OF PROXY MUST BE INITIALLED BY THE PERSON(S) WHO SIGNS IT.**

IF YOU WISH TO VOTE ABSTAINED ANY RESOLUTION, PLEASE TICK THE BOX MARKED "ABSTAINED". A SHAREHOLDER (INCLUDING HIS/HER PROXIES) ENTITLED TO TWO OR MORE VOTES NEED NOT CAST ALL THE VOTES FOR OR AGAINST OR ABSTAINED, BUT COULD INSERT RELEVANT NUMBER OF SHARES IN THE COLUMN.** Where there are ballots on which the words are not filled in, wrongly filled in or unintelligible or the ballots that are not voted, the voters shall be regarded as having relinquished their voting rights and the voting results of their shares shall be regarded as "abstention". If no direction is given, the proxy will be entitled to vote as he/her thinks fit. Unless you have indicated otherwise in this proxy form, your proxy will be also entitled to vote at his/her discretion on any other resolution properly put to the EGM.
7. This proxy form must be signed by you, or your attorney duly authorised in writing or, if you are a corporation, must either be executed under the common seal or under the hand of the person-in-charge or duly authorised attorney(s).

To be valid, the proxy form together with any power of attorney or other authority (if applicable) under which it is signed or a notarially certified copy of that power of attorney or authority must be lodged by the H Shareholders of the Bank at the H Share registrar of the Bank, Computershare Hong Kong Investor Services Limited, whose address is at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong, not less than 48 hours before the time fixed for holding the EGM (or 48 hours before any adjournment thereof, if any).
9. Return of the proxy form will not preclude a shareholder from attending and voting in person at the meeting or any adjournment thereof if he so wishes, but in such event the instrument appointing a proxy shall be deemed to be revoked.

PERSONAL INFORMATION COLLECTION STATEMENT

"Personal Data" in this form of proxy has the same meaning as "personal data" in the Personal Data (Privacy) Ordinance, Cap 486 ("PDPO"), which includes your and your proxy's name and address.

You and your proxy's Personal Data provided in this form of proxy will be used in connection with processing your request for the appointment of a proxy to attend, act and vote on your behalf as directed above at the EGM. The supply of your and your proxy's Personal Data is on a voluntary basis. However, the Bank may not be able to process your request unless you provide us with your and your proxy's Personal Data.

Your and your proxy's Personal Data will be disclosed or transferred to the Bank, the Bank's H Share registrar and/or professional advisors of the Bank for the purpose stated above, or when it is required to do so by law, and will be retained for such period as may be necessary for our verification and record purpose. By providing your proxy's Personal Data in this form of proxy, you should have obtained the express consent (which has not been withdrawn in writing) from your proxy in using his/her Personal Data provided in this form of proxy and that you have informed your proxy of the purpose for and the manner in which his/her Personal Data may be used.

You/your proxy have/has the right to request access to and/or correction of your/your proxy's Personal Data respectively in accordance with the provisions of the PDPO.
